Retail Profits

There are two ways of earning Retail Profits. Associates may purchase Isagenix products directly from the company at wholesale, which may be used by the Associate for personal consumption or may be sold to a customer. A Retail Profit occurs when an Associate sells product to a customer above the wholesale price. Associates can also make Retail Direct Profits by sending a customer to their web site to purchase Isagenix Products.

Product Introduction Bonus

You will receive a one time Product Introduction Bonus of \$10 to \$30 when you sign up a new Associate who chose at the time of sign up to purchase an optional Isagenix Product Introduction Pak.

Team Bonuses

As a qualified Consultant, you are eligible to earn Team Bonuses. A successful Isagenix Consultant will build a 2 team marketing organization, which means you will build 2 sales teams. For simplicity, we will call these 2 sales teams your Left Sales Team and your Right Sales Team . When you accumulate 900 points in Group Volume (GV) and at least 300 of those points came from one of your sales teams and 600 points came from your other sales team, you earn a team bonus of \$63. This is called a Cycle, and your Retail Business Center can Cycle multiple times every day. Note: A Retail Business Center's income is limited to U.S. \$50,000 per week, calculated daily, paid weekly.

Executive matching Bonuses

As a qualified Executive you may earn a 10% Matching Bonus on the weekly team bonus income of all the Isagenix Associates you personally enrolled. **Getting Started With Isagenix**

Becoming An Isagenix Associate

To become an Associate, submit an Independent Associate Application or complete an Online Enrollment Form. A \$36 annual membership fee is required with your initial Application or Online Enrollment. As an Associate, you will receive your own self replicating web site plus unlimited access to your back office management support center for one year. You will also be entitled to purchase wholesale directly from Isagenix and earn Retail Profits and Retail Direct Profits plus be eligible for the Product Introductory Bonus.

As an Associate you will receive a Retail Business Center which must be qualified.

Becoming An Isagenix Consultant

You become a Consultant by activating your Retail Business Center. This is accomplished by accumulating a minimum of \$100 Personal Volume (PV) and personally enrolling 2 associates. One Associate on your Left Sales Team and One Associate on your Right Sales team who have also each accumulated \$100 Personal Volume (PV) within 30 days. IN addition to the Associate benefits listed above, once you are a Consultant you are eligible to receive Team Bonuses of up to U.S. \$50,000 a week and your volume never flushes as long as you maintain a monthly PV of \$100.

Becoming An Isagenix Executive

You become an Executive by personally enrolling 10 Consultants. In addition to the Associate and Consultant benefits listed above, once you are an Executive you are eligible to receive a 10% Matching Bonus on the weekly team bonus income of all the Isagenix Associates you personally enrolled.

According to Dr. Charles King, University of Illinois at Chicago, companies that "Go Big", will go through 4 distinct phases of growth.

Formation, Concentration, Momentum and Stability.

The Formation phase is just what it implies . . . a company is born. It is in this time that the systems for growth are put in place. When a company's monthly sales reach about 1 million, they begin to transition into the second growth phase, Concentration.

The Concentration phase is where the company starts to "Dial-In", fine tuning it's systems, products and marketing message. When a company reaches 4-5 million in monthly sales a dramatic shift occurs. This point is called "Critical Mass" and it marks the point where the companies growth curve turns virtually vertical. This phase is called Momentum and usually lasts 18-36 months.

Momentum growth is exhilarating and can be extended by new product introductions and new market introductions (New Countries). Once a company has gone through Momentum they reach the final stage of growth, Stability.

When a company reaches Stability their growth curve looks a lot like the curve from concentration which means solid, stable growth.

Isagenix has moved into the Concentration Phase of Growth and is marching rapidly towards "Critical Mass".

A Network Marketing Company will bring on 80% of their sales force during the Momentum phase of growth. In that 18 - 36 months Isagenix products and opportunity will transition from obscure to popular.
